

The 125 rule for breakers is a National Electrical Code requirement that states circuit breakers must be sized at 125 percent of the continuous load on that circuit. 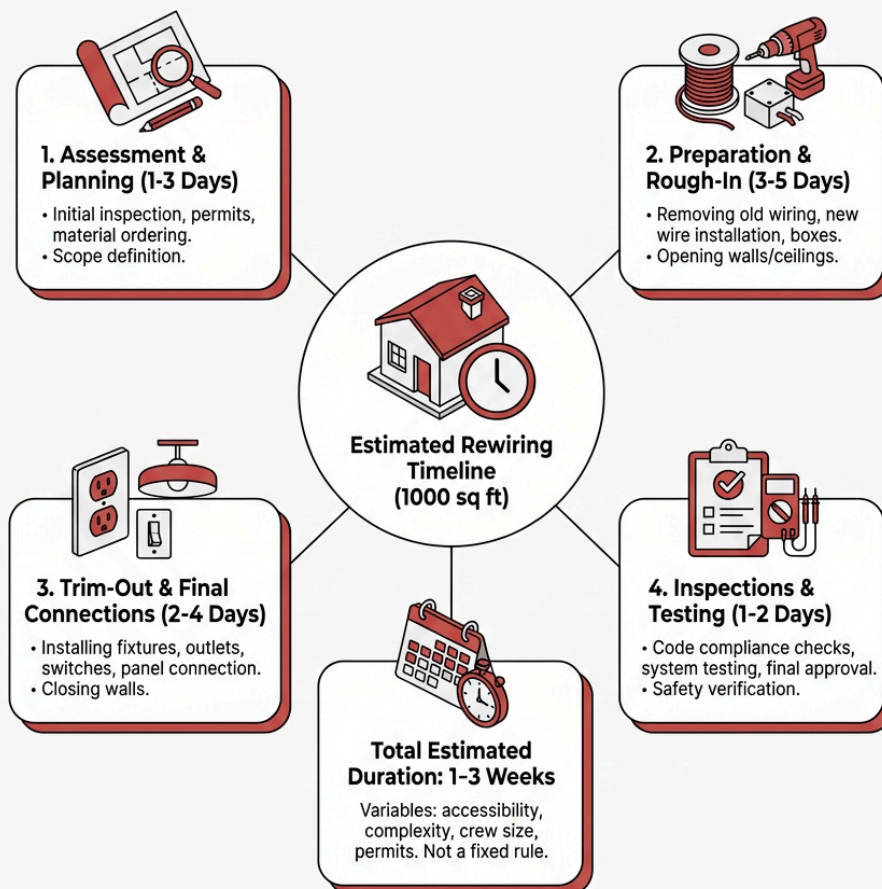
