

A tree can add shade, privacy, beauty, and long-term value to a property. It can also become a genuine hazard when structural weakness, storm damage, poor pruning history, or site pressure changes the way that tree behaves. Most owners do not need every tree to be perfect. They do need a clear understanding of which trees present a meaningful risk, what can be corrected, and when removal is the responsible choice.
