

When **truck accident lawyer** someone is hurt in a bus collision in Georgia, there is a clock most people never hear about.

The general Georgia deadline for injury suits is two years. A claim against a city, county, transit authority or school district can require written notice in a fraction of that time, and it has to be in the right form and go to the right place.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
