

Queens rewards the curious visitor. It does not always announce itself with the swagger of Manhattan or the cinematic shorthand of Brooklyn, yet it holds some of New York's richest stories in plain sight. A single afternoon can take you from a landmark park built for world's fairs to a block lined with Tibetan, Colombian, Filipino, or Greek businesses, then on to a quiet residential street where brick rowhouses and detached homes tell another chapter of the borough's growth.
