

Why the Anion Gap Measures

The **anion gap** is a useful way to measure **electrolyte imbalance** and determine whether the body's **acid-base balance** is moving into an abnormal state. It is not a direct measurement of a single substance. Instead, it shows the difference between measured positively charged and negatively charged particles in the blood, helping clinicians detect hidden problems in the bloodstream.

Albumin also influences the baseline result because it is a major unmeasured anion in blood. 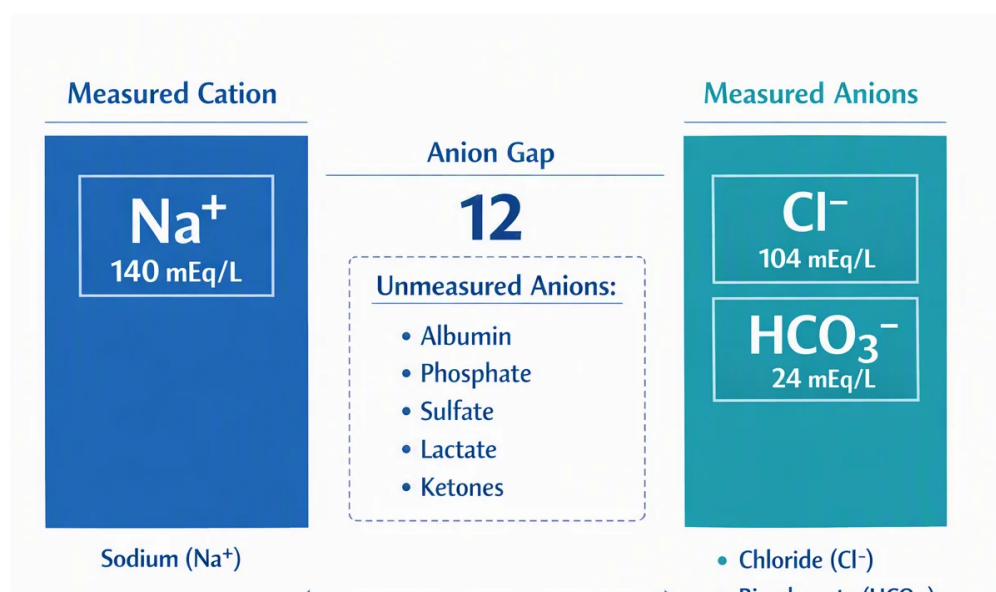
