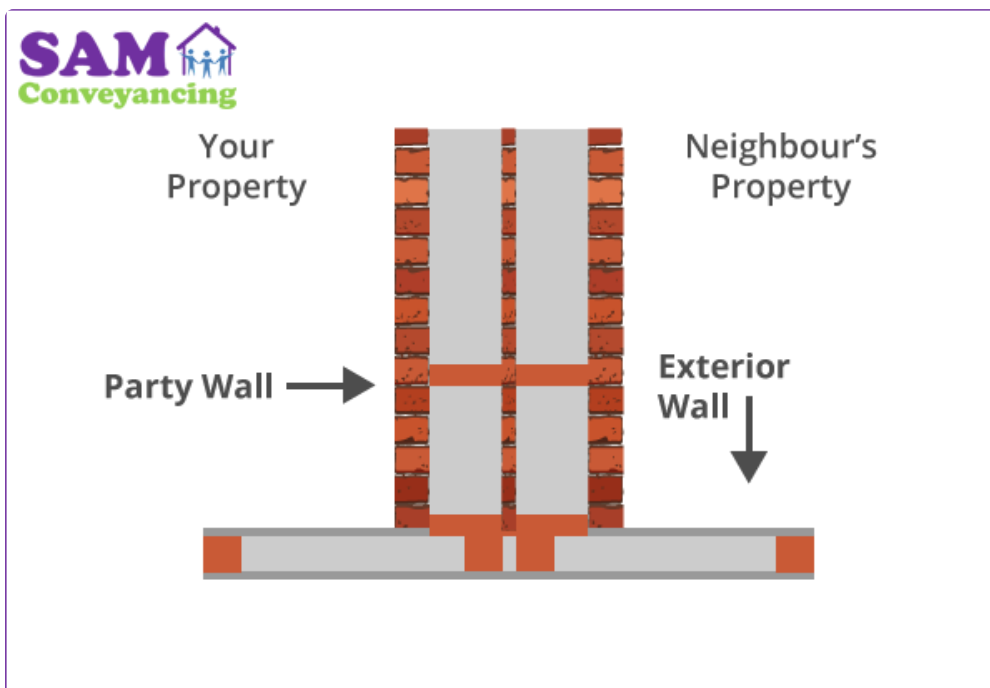

If your job includes work on or near a party wall, or excavation near to an adjoining building, you are legally needed to serve notification on your neighbours prior to beginning.
