

What Is the Anion Gap?

The anion gap is a clinically helpful way to evaluate acid-base balance by comparing the major measured electrolytes in the serum chemistry. It is not a literal measurement of a specific substance; instead, it approximates the difference between measured cations and measured anions, allowing clinicians [anion gap clinical significance](#) infer the presence of unmeasured anions and unmeasured cations.

In typical clinical interpretation, the standard version uses sodium, chloride, and bicarbonate. The exact reference range can vary by laboratory method, so the number should always be compared with the local reference range.

In blood gas interpretation, this pattern often appears with a low pH, reduced bicarbonate, and respiratory compensation through a lower PaCO₂.

Common causes include lactic acidosis, ketoacidosis, and renal failure. Lactic acidosis can occur when tissue hypoperfusion, hypoxia, or impaired metabolism raises lactate production. Ketoacidosis is often seen when ketone bodies build up, such as in diabetes, starvation, or alcohol-related states. A high anion gap therefore functions as a physiologic marker, not just a number. It suggests that the acid-base disturbance reflects true acid accumulation rather than simple bicarbonate loss.

When the anion gap is high, think about the clinical context: perfusion status, glucose, ketones, kidney function, lactate, and exposure history. How to Check for Mixed Acid-Base Disorders

The anion gap is especially helpful when the blood gas doesn't align with a single clear diagnosis. A mixed disorder may occur when more than one acid-base process is occurring at the same time. This is where the delta gap and delta-delta calculations become helpful.

The delta gap relates the rise in anion gap to the fall in bicarbonate. If the anion gap increases more than expected relative to the bicarbonate drop, there may be an additional metabolic alkalosis or a concurrent disorder that dampens the expected acidosis.
