

A truck wreck is not a car wreck. A fully loaded truck can outweigh your car many times over, and people tend to get hurt much worse.

The difference starts in the first [truck accident lawyer](#) hours. The trucking company often sends its own people to the scene before the road is even clear, while you are still in the emergency room. They start protecting the company immediately.

## **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. ## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
