

If you were hurt by electrical contact in Atlanta, there is usually more than one responsible party.

There is the property owner, a general contractor, the electrical subcontractor, sometimes a utility, occasionally an equipment maker, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a **truck accident lawyer** claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, since comp covers none of the human loss and only part of the financial one.

Working [Website link](#) out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
