

If a dog bit you in Georgia, the rules may not be what you assume.

Some states hold the owner responsible no matter what. Georgia does <https://blogfreely.net/benjintac/h1-b-wrongful-death-cases-throughout-fulton-county-what-the-law-calls-the> not work that way. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Establishing what the owner knew is not easy. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. Animal control files and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
