

When a dog attack leaves someone hurt in the Atlanta area, Georgia works differently than people expect.

Certain states impose liability regardless of the animal's history. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. Owners rarely volunteer that a [local Atlanta injury lawyer](#) dog has snapped before, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, which is why the first questions are about where the dog was and whether anyone contacted animal control.

Records disappear quickly here. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
