

If an electrical injury happened at work in Georgia, there is usually more than one responsible party.

There is the property owner, the general contractor, the electrical sub, sometimes a utility, occasionally an equipment maker, and sometimes a staffing agency. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not stop a claim against another company that caused the danger.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
