

When a dog attack leaves someone hurt around Atlanta, the legal standard surprises most people.

In some places an owner is liable automatically. Georgia does not work that way. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, which is why the first questions are [truck accident lawyer](#) about where the dog was and whether a complaint was ever filed.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
