

What Is an Anion Gap?

The **anion gap** is a calculated value used in **laboratory interpretation** to support the assessment of **acid-base balance** and identify certain **acid-base disorders**. It evaluates the main measured **electrolytes** in blood, especially **sodium**, **chloride**, and **bicarbonate**, to estimate the balance between unmeasured positively and negatively charged particles in the bloodstream.

In simple terms, the anion gap reflects **charge balance** in a blood sample. A normal value suggests the measured ions are in a typical relationship, while an **abnormal result** can be a **diagnostic clue** for conditions such as **metabolic acidosis** or a protein-related change in serum chemistry. How an Anion Gap Calculator Operates

An **anion gap calculator** draws on values from standard blood test results to compute the **anion calculation**. 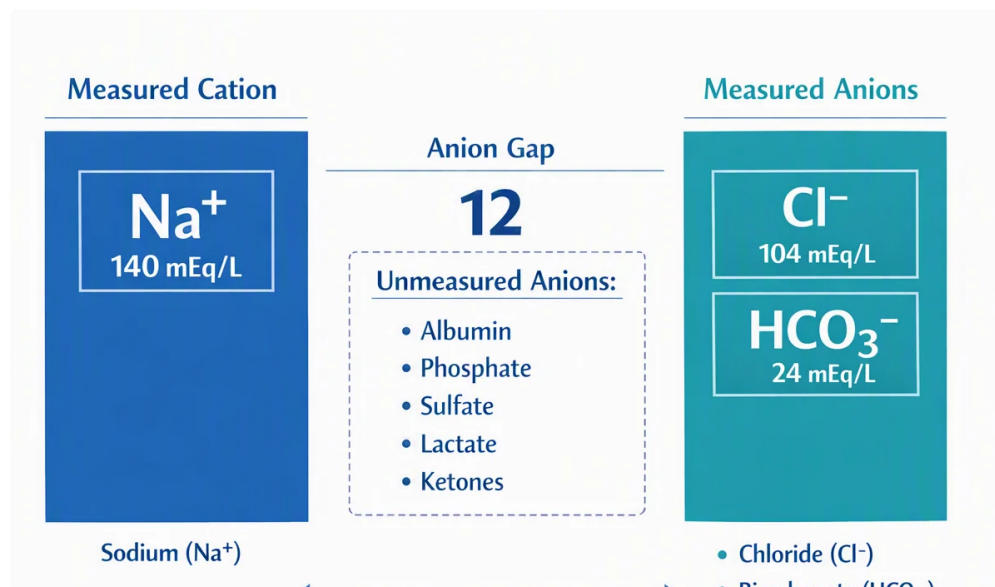

Albumin correction is especially useful when a low albumin level might be hiding the true acid-base status. Since albumin is a major unmeasured anion, low albumin can lower the anion gap and make the value seem less concerning than it really is.
