

What Is the Anion Gap?

The **anion gap** is a derived measurement calculated from common **electrolytes** in a **serum chemistry panel**. It assists clinicians assess **acid-base balance** and detect types of **acid-base disorders**, especially when reviewing possible **metabolic acidosis**. Although it is not a directly measured number, it reflects the difference between major positively charged and negatively charged particles in **blood chemistry**.

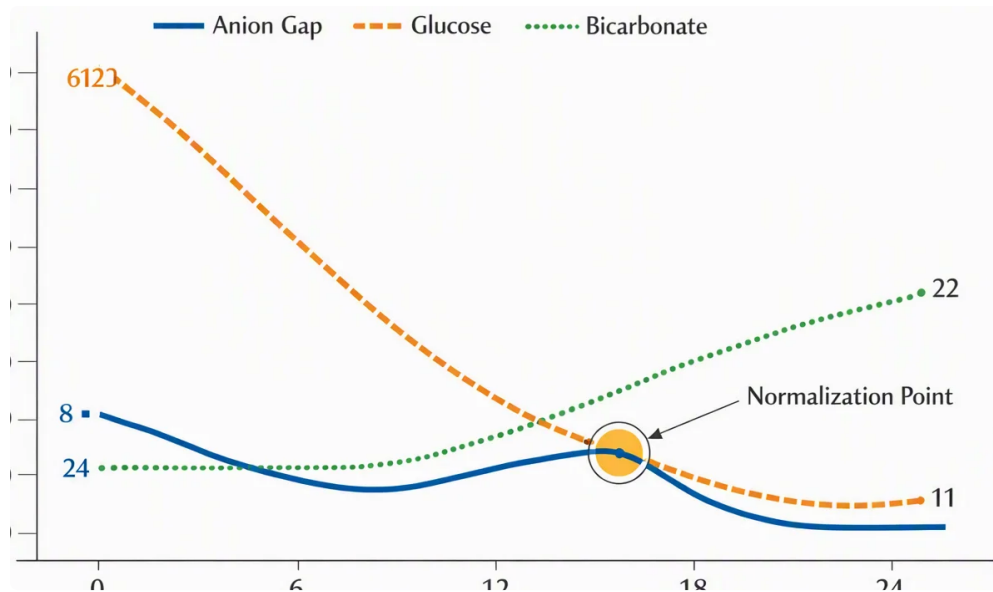
Anion gap = sodium - (chloride + bicarbonate)
