

When a dog attack leaves someone hurt in the Atlanta area, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia does not work that way. Usually it comes down to whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has [truck crash lawyer](#) snapped before, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether a complaint was ever filed.

Records disappear quickly here. County records and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
