If the app is off, it is an ordinary car wreck, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each position can reach a [atlanta personal injury attorney](#) different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
