

If an electrical injury happened at work in Georgia, there is usually more than one responsible party.

There is the property owner, the general contractor, the electrical subcontractor, sometimes a utility, occasionally an equipment maker, and sometimes a staffing agency. Each carries its own coverage and its own reason to blame someone else.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it prevents [18-wheeler accident claim lawyer](#) you from suing the employer directly. It does not stop a claim against another company that caused the danger.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
