

A truck wreck is not a car wreck. A fully loaded truck can outweigh your car many times over, and the injuries are usually far worse.

The difference starts in the first hours. Trucking companies frequently send an investigator to the scene within hours, while you are still in the emergency room. They begin building the company's side of the case right away.

A lot of it can be purged in the ordinary course of business, which is why a preservation demand usually goes out early.
