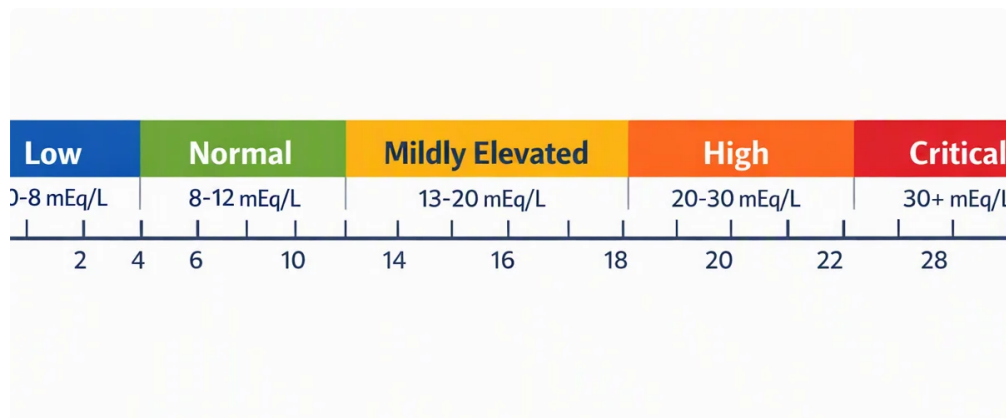


What Is the Anion Gap and Why Does It Matter?

The **anion gap** is a calculated value that helps clinicians assess **acid-base balance** and detect hidden causes of **metabolic acidosis**. It compares the main measured **electrolytes** in the blood, especially **sodium** and **chloride**, to estimate whether unmeasured acids are building up in the body. When the gap is above normal than expected, it often signals an **acid-base disturbance** caused by **unmeasured anions**.

The main **antidote** is **fomepizole**, which blocks the metabolism of ethylene glycol into its toxic acids.
