

If you or your child were bitten in Georgia, the legal standard surprises most people.

Some states hold the owner responsible no matter what. Georgia does not work that way. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. People **Click for more info** do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

This evidence does not last. Prior complaints and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
