

A rideshare wreck raises a question a normal car crash does not: [atlanta personal injury attorney](#) which insurance policy actually applies. The answer depends on what the driver was doing at that exact moment.

When the app is off, the driver is just a driver, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a technicality. It [local Atlanta PI attorney](#) can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each position can reach a different layer of coverage.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
