

If you or your child were bitten around Atlanta, the rules may not be what you assume.

A leash law violation is often the clearer path, which is why the first questions are about where the dog was and whether a complaint was ever filed.

This evidence does not last. Prior complaints and recollections both fade, and the dog [truck accident lawyer](#) itself may be gone before anyone captures what it had done before.
