

If you were riding and were hit in Atlanta, there is a prior you have to overcome.

People arrive with a view already formed: that the rider was going too fast, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes that is accurate. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, because narrative starts at a disadvantage. Damage patterns carry more weight than either version of events.

Injury severity cuts both ways. There is nothing around a rider, so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
