

What's the Anion Gap?

The **anion gap** is a computed measure used in **electrolyte panel** review to evaluate **acid-base balance** and detect possible causes of an **electrolyte imbalance**. It is not directly measured on a **blood test**; instead, it is calculated from common **serum chemistry** results, usually from a **basic metabolic panel** or **comprehensive metabolic panel**.

$$\text{Anion gap} = \text{sodium} - (\text{chloride} + \text{bicarbonate})$$

The reason the formula works is that routine electrolyte testing measures only a portion of the charged particles in blood. The remaining difference represents the "gap," which can hint at **organic acids**, other **unmeasured ions**, or changes in protein levels. For example, if sodium is 140, chloride is 100, and bicarbonate is 24, the calculation is $140 - (100 + 24) = 16$. That result may be interpreted differently depending on the lab's **reference interval** and the patient's complete clinical picture.

A **normal anion gap** depends on the **lab reference range** applied by the testing facility as well as whether the calculation includes potassium. In practice, a high value suggests that the measured bicarbonate has been consumed buffering excess acid, while the gap expands because of accumulated **acidic byproducts** or other retained anions. That makes the result a valuable clue during **patient assessment**, especially if symptoms such as rapid breathing, confusion, vomiting, dehydration, or altered mental status are present.

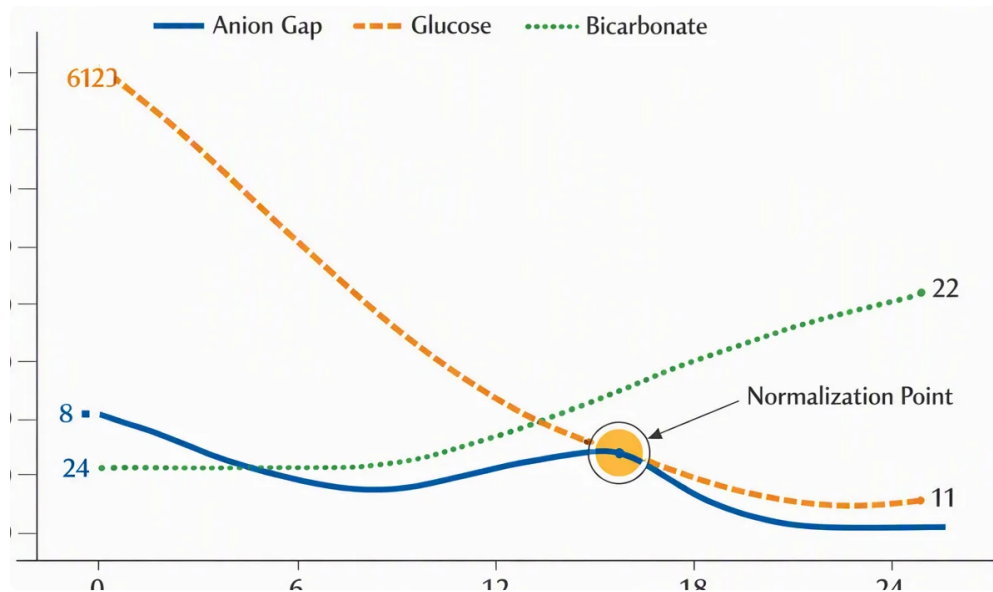
What Leads to a Low Anion Gap?

A **low anion gap** is rarer than a high one, but it can still be medically significant. The leading explanation is **hypoalbuminemia**, because albumin is a major negatively charged protein in blood. When albumin falls, the gap often declines too.

Additional causes to consider include:

- **Lab error** or specimen issues, which should always be ruled out first.
- **Multiple myeloma** or related plasma cell disorders, which can alter protein patterns and change measured relationships.
- Presence of **unmeasured cations**, such as specific medications or electrolyte abnormalities that alter the balance of charged particles.

A low result may be overlooked because it does not always signal an emergency, but it can provide a valuable clue. For example, a persistently low value alongside anemia, kidney dysfunction, bone pain, or abnormal protein studies may support further evaluation for **multiple myeloma**. Likewise, a sudden isolated low result should prompt consideration of **lab error** before deeper workup.



Although the phrase “anion deficit” is sometimes used loosely, the key concept is the same: a reduction in the expected difference between measured cations and anions. That difference often reflects changes in proteins, measurement artifacts, or **unmeasured ions**.
