

If you or your child were bitten around Atlanta, the rules may not be what you assume.

In some places an owner is liable automatically. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

This evidence does not last. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
