

If you were riding and were hit in Atlanta, there is a prior you have to overcome.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes it fits. More often a driver looked and did not register a single headlight.

The work is physical evidence, not story, since the story is doubted before it is told. Scene measurements do the arguing.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
