

When someone is hurt in a bus collision in Atlanta, the timeline is not the usual one.

The general Georgia deadline for injury suits is two years. Where a government entity owns the bus, written notice may be due in months rather than years, in a specific form, to a specific office.

Missing that notice can end an otherwise strong case before it starts.

Ownership determines almost everything here. A public bus, a school bus and a private charter are three different cases. It sets the deadline, the immunity analysis and what insurance responds.

There is a second deadline nobody announces. Buses are heavily camerad, inside and out, and footage is frequently overwritten within weeks. Ask too late and there is nothing left to preserve.
