

If you ride and a driver did not see you in Atlanta, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes that is accurate. Usually the car turned left across a rider who had **truck accident lawyer** the right of way.
