

What the Anion Gap Measures

The **anion gap** is an effective method to evaluate the balance of charged particles in the blood. It is calculated from common **electrolytes** and helps clinicians judge **acid-base balance**, especially when evaluating **metabolic acidosis**. Although it is not a direct measurement of all acids in the body, it provides a practical window into whether there are extra *unmeasured anions* affecting blood chemistry.

In basic terms, the anion gap compares the positively charged *anion gap ethylene glycol methanol* ions, mainly sodium, against the negatively charged ions, mainly chloride and bicarbonate. If the gap is higher than expected, it can suggest that acid is accumulating in a way that is not fully reflected by the standard electrolyte panel. That makes it an important screening and interpretive tool in many forms of *acid-base disorder*.

Because the anion gap is calculated from routine lab values, it is often used as a **diagnostic tool** rather than a standalone diagnosis. The logic is simple: less albumin means fewer negatively charged proteins contributing to the normal baseline, so the measured value may fail to reflect the true gap.

variation, the central idea remains the same: account for albumin before concluding that the anion gap is normal.

Why Albumin Affects the Result

Step by step Example Calculation

- Na: 138 mmol/L
- Chloride: 102 mmol/L
- HCO₃: 22 mmol/L
- Albumin: 2.5 g/dL

To begin, calculate the **measured anion gap**:

$$138 - 102 - 22 = 14$$

Next apply the albumin adjustment:

$$\text{Corrected value} = 14 + 2.5 \times (4.0 - 2.5)$$

$$\text{Adjusted value} = 14 + 2.5 \times 1.5 = 14 + 3.75 = 17.75$$

The corrected result is greater than the measured one. That variation may influence the **medical interpretation**, especially if the patient appears to have **acidosis** or another **acid-base imbalance**. What looked marginal could actually represent a more significant gap once albumin is accounted for.

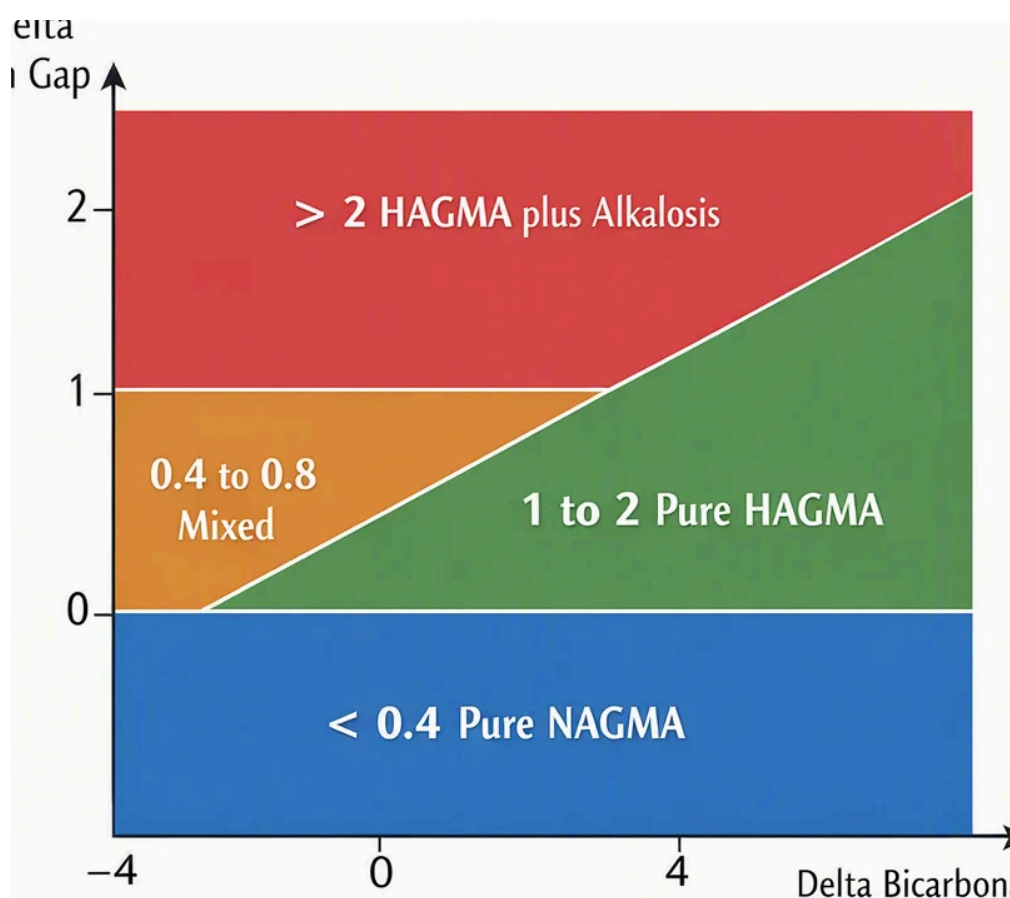
Common Causes of a Standard or Decreased Anion Gap

A **standard anion gap** is often linked to **hyperchloremic metabolic acidosis**, where bicarbonate falls and chloride rises in a counteracting pattern that keeps the calculated gap from increasing. This can happen in gastrointestinal fluid loss, certain kidney tubular problems, or after certain infusions and medicines.
