- Optional supplemental coverage.

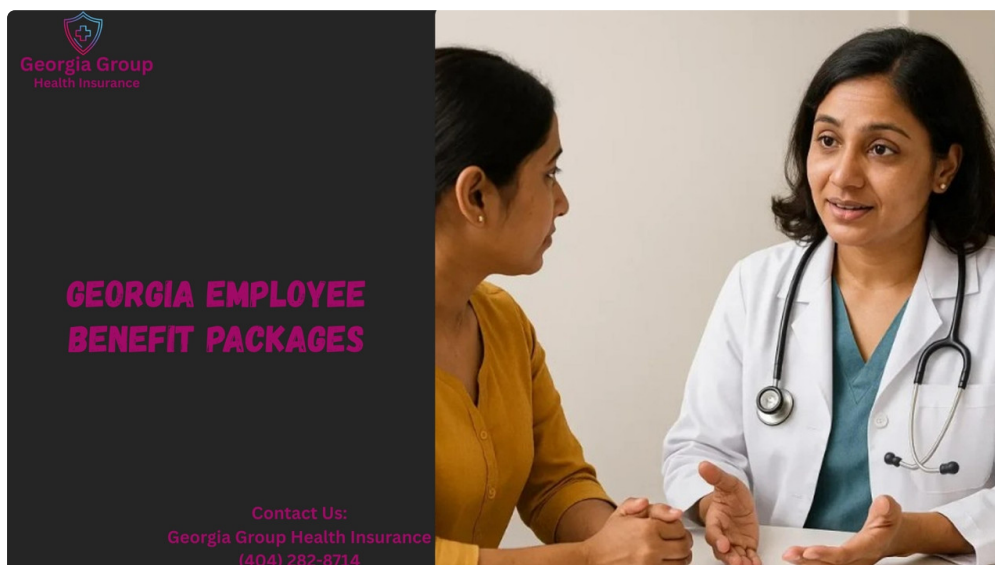

Recruitment and retention value

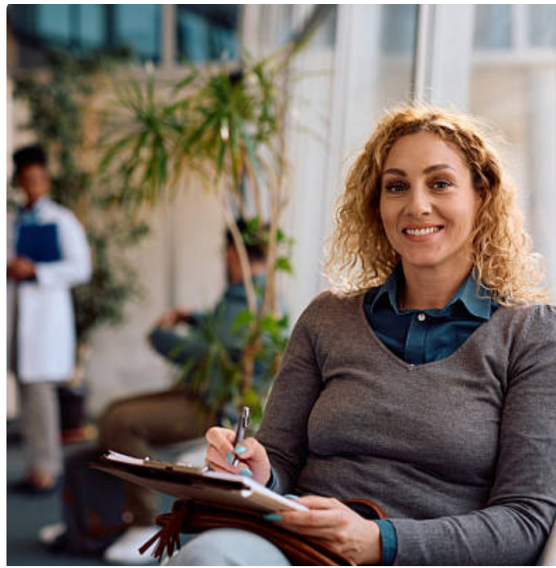
