

If you were riding and someone turned across your path in Georgia, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was lane splitting or weaving, **Go here** or took a risk a car driver would not.

Sometimes it fits. More often a driver looked and did not register a single headlight.

The work is physical evidence, not story, because narrative starts at a disadvantage. Sight line analysis carry more weight than either version of events.

Injury severity cuts both ways. There is nothing around a rider, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted that risk by riding at all.
