

If you ride and a driver did not see you around Atlanta, there is a prior you have to overcome.

There is a built in bias in motorcycle claims: that the rider was going too fast, was weaving through traffic, or accepted [Learn more here](#) a risk nobody else would.

Sometimes it fits. Frequently the driver simply did not see the motorcycle and turned across it.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Sight line analysis carry more weight than either version of events.

Injury severity cuts both ways. There is nothing around a rider, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
