

If you were riding and someone turned across your path around Atlanta, the assumption is already working against you.

There is a built in bias in motorcycle claims: that the rider was [experienced personal injury lawyer](#) going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Occasionally that is true. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. Sight line analysis carry more weight than either version of events.

Severity helps and hurts. There is nothing around a rider, so identical forces cause much greater harm. Expect an argument [truck accident lawyer](#) that choosing to ride was itself the risk.
