

What the Anion Gap Measures

The **anion gap** is a helpful way to measure the link between measured **electrolytes** in a **serum chemistry** panel and the body's overall **acid-base balance**. It reflects the gap between common positively charged and negatively charged ions and aids identify whether an **acid-base disorder** is present, especially **metabolic acidosis**. Clinicians apply it as a **diagnostic aid** because an abnormal result can suggest extra acids in the blood or to a shift in the balance of ions that would otherwise be missed on routine lab values.

Anion gap = serum sodium - (serum chloride + serum bicarbonate)

Some equations include **serum potassium**:

Anion gap = (serum sodium + serum potassium) - (serum chloride + serum bicarbonate)

This version omitting potassium is used frequently because potassium is usually minor relative to the other ions and may vary less in everyday interpretation. Still, knowing whether potassium is included matters when comparing results across different calculators or reports. The key inputs are the **chloride level** and **bicarbonate level**, since these values directly affect the final number.

Each input represents part of the body's **serum chemistry** profile. Sodium is the main measured cation, while chloride and bicarbonate are the main measured anions in routine testing. If bicarbonate drops, the gap may rise if chloride does not rise enough to offset the change. If chloride rises, the gap may fall even if the patient still has an acid-base problem. Further clues help refine the assessment:

- Increased **lactate** supports lactic acidosis.
- Hyperglycemia and ketones suggest ketoacidosis.
- An increasing creatinine level may point toward renal impairment or renal failure.
- Reported exposure raises concern for toxic alcohols.

Reasons for a Decreased or Below-zero Anion Gap

A **reduced anion gap** or even a below-zero result is infrequent and should prompt thorough evaluation. One frequent cause is **hypoalbuminemia**, since albumin is an important negatively charged protein that helps create the gap. When albumin is low, the gap may look artificially diminished even if the acid-base state is otherwise stable.

Another possibility is **laboratory error** or other **analytical error**. A mislabeled sample, instrument issue, or specimen problem can distort sodium, chloride, or bicarbonate values. Because the formula depends on these inputs, even a slight error can shift the result substantially. This is why unexpected values often justify **repeat testing**.

A **corrected anion gap** raises the reported value upward to account for reduced albumin. Assessing **protein status** helps determine whether the reported gap is truly normal or simply obscured by low albumin. When albumin is low, keep in mind:

- Whether the uncorrected gap may underestimate acid burden
- Whether the patient has chronic illness or malnutrition

Assessing Results with Other Lab Values
