

If you were hurt by electrical contact around Atlanta, there is usually more than one responsible party.

A site has an owner, the general contractor, the electrical sub, sometimes a utility, sometimes an equipment manufacturer, and sometimes a staffing agency. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion [truck accident law firm](#) of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

That third party claim is usually where the real recovery sits, since comp covers none of the human loss and only part of the financial one.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, and none of that is available just for the asking.
