

If you were riding and a driver did not see you in Atlanta, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was lane splitting or weaving, or accepted a risk nobody else would.

Sometimes that is accurate. Frequently the driver simply did not see the motorcycle and turned across it.

Reconstruction matters more here than testimony, because narrative starts at a disadvantage. Sight line analysis do the arguing.
