

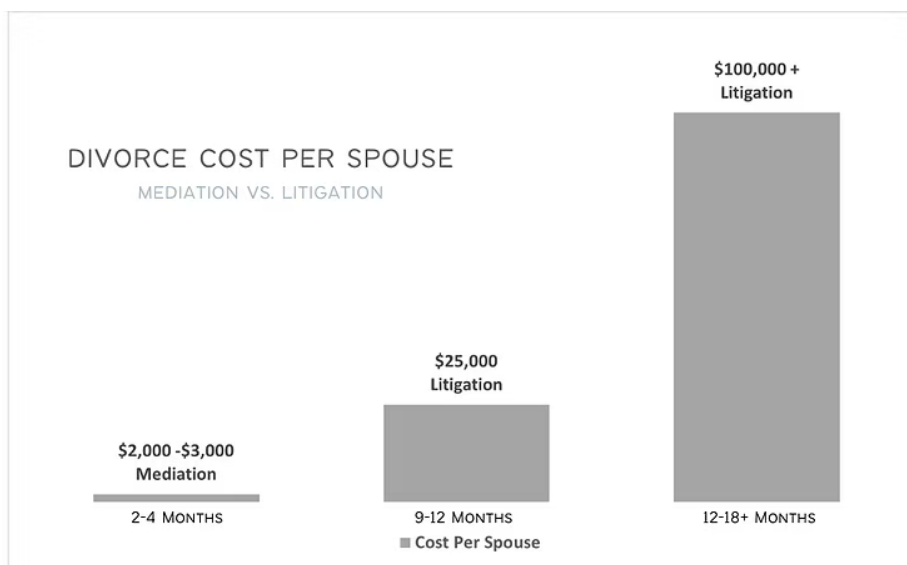
- **Mandatory mediation**: legal imperative
