- It needs to be kept in mind that the fourteen-day period only relates to Honors which are valid.

- The Act calls for the building owner, the individual performing the works, to serve notification on the adjoining owner prior to beginning certain kinds of work.
- By offering you with a Notification they are starting the procedure and are informing you of the work they wish to have actually executed to their building for which you may share a Party Wall surface or are within close distance within their recommended work.
- Nevertheless, typically the influence on the neighbours can be considerable, especially with the loss of light into adjoining spaces.
