

If a dog bit you in the Atlanta area, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia does not work that way. Usually it comes down to whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

Establishing what the owner knew is not easy. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained **truck accident lawyer** and whether a complaint was ever filed.

Records disappear quickly here. Animal control files and witness memory both degrade, and the dog itself may **local lawyer for truck accident** be gone before anyone captures what it had done before.
